RESOLUTION NO. 01

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 007, SERIES OF 2014 OF THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 007, Series of 2014 of the Municipality of Buenavista authorizing its Supplemental Budget No. 006, Series of 2014 involving an appropriation of Two Million Four Hundred Fifty Four Thousand Two Hundred Thirty Five Pesos (P2,454,235.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, duly seconded by SP Members Cyril C. Beltran, Rex G. Fernandez and Dan Elby C. Habaña.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 007, Series of 2014 of the Municipality of Buenavista, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 007, Series of 2014 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

- 1. The grant of Productivity Enhancement Incentive (PEI) to the Municipal Officials and employees shall be subject to the provisions of Department of Budget and Management, Budget Circular No. 2014-3 dated December 2, 2014.*
- 2. The 5% Local Disaster Risk Reduction Management Fund shall be utilized for the expenditures authorized under RA 10121, JMC 2013-1 of NDRRMC-DBM-DILG dated March 25, 2013 and COA Circular No. 2012-1.*

3. *The fund utilization for the 20% Development Fund shall be in accordance with the approved Annual Investment Plan of the Municipality and subject to the provisions of DILG-LBM Joint Memorandum No. 2011-1 dated April 13, 2011.*

RESOLVED FURTHER, to require the Municipality of Buenavista to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to inform the Municipality of Buenavista that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.


