RESOLUTION NO. 02

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 20-2014 OF THE MUNICIPALITY OF SIBUNAG, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 20-2014 of the Municipality of Sibunag authorizing its Supplemental Budget No. 05-2014 involving an appropriation of One Million Thirty Five Thousand Pesos (P1,035,000.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, unanimously seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED to declare Appropriation Ordinance No. 20-2014 of the Municipality of Sibunag, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 20-2014 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

- 1. The grant of Productivity Enhancement Incentive (PEI) to the Municipal Officials and employees shall be subject to the provisions of Department of Budget and Management, Budget Circular No. 2014-3 dated December 2, 2014.*
- 2. The disbursement of funds shall not exceed the amount authorized in the Appropriation Ordinance.*


RESOLVED FURTHER, to require the Municipality of Sibmug to comply with the herein conditions and notify this body of actions taken thereon


