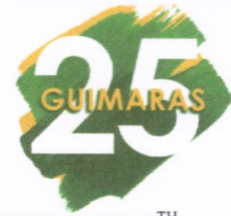



Section 2. This Appropriation Ordinance shall take effect upon its approval.


