AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 02, CY 2016 INVOLVING THE AMOUNT OF TWO MILLION FIVE HUNDRED FORTY EIGHT THOUSAND PESOS (\$\frac{p}{2}\$,548,000.00) TAKEN FROM THE LOAN PROCEEDS FROM LAND BANK OF THE PHILIPPINES (LBP) IN THE AMOUNT OF TWO MILLION FIVE HUNDRED FORTY EIGHT THOUSAND PESOS (\$\frac{p}{2}\$,548,000.00) TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT OF GUIMARAS

Be it enacted in the Regular Session assembled:

Section 1. Supplemental Budget No. 02 of the Provincial Government of Guimaras for CY 2016 in the amount of Two Million Five Hundred Forty Eight Thousand Pesos (\$\mathbb{P}\$2,548,000.00) taken from the loan proceeds from Land Bank of the Philippines (LBP) in the amount of Two Million Five Hundred Forty Eight Thousand Pesos (\$\mathbb{P}\$2,548,000.00) to cover various expenditures of the Provincial Government of Guimaras is hereby approved.
