**APPROPRIATION ORDINANCE NO. 04**

Series of 2016

**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 02, CY 2016 INVOLVING THE AMOUNT OF TWO MILLION FIVE HUNDRED FORTY EIGHT THOUSAND PESOS (P2,548,000.00) TAKEN FROM THE LOAN PROCEEDS FROM LAND BANK OF THE PHILIPPINES (LBP) IN THE AMOUNT OF TWO MILLION FIVE HUNDRED FORTY EIGHT THOUSAND PESOS (P2,548,000.00) TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT OF GUIMARAS**

Be it enacted in the Regular Session assembled:

**Section 1.** Supplemental Budget No. 02 of the Provincial Government of Guimaras for CY 2016 in the amount of Two Million Five Hundred Forty Eight Thousand Pesos (P2,548,000.00) taken from the loan proceeds from Land Bank of the Philippines (LBP) in the amount of Two Million Five Hundred Forty Eight Thousand Pesos (P2,548,000.00) to cover various expenditures of the Provincial Government of Guimaras is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

1. Certification from the Provincial Treasurer as to fund availability.
2. Itemized funding allocation request from the Honorable Governor.

**Section 2.** Sources of Funds. The source of funds for Supplemental Budget No. 01 is as follows:

Loan Proceeds from Land Bank of the Philippines	P2,548,000.00
Total Available for Appropriations	P2,548,000.00

**Section 3.** Use of Funds. The amount of Two Million Five Hundred Forty Eight Thousand Pesos (P2,548,000.00) is hereby appropriated for Supplemental Budget No. 02, CY 2016 of the Provincial Government of Guimaras, as follows:

**Section 4.** Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

**Section 5.** Effectivity. The provisions of this Ordinance shall take effect upon approval.


**Section 6** Copies of this Appropriation Ordinance be furnished the Office of the Governor, DCGNPH, Provincial Budget Officer, Accountant, Treasurer, Commission on Audit and all others concerned, for information and appropriate action.
