RESOLUTION NO. 08

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 13-2014 OF THE MUNICIPALITY OF SIBUNAG, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 13-2014 of the Municipality of Sibunag authorizing its Annual Executive Budget for Budget Year 2015 involving an appropriation of Sixty Million Seven Hundred Sixty Eight Thousand Nine Hundred Ninety Three Pesos (P60,768,993.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, duly seconded by SP Members Diosdado G. Gonzaga, Josefina G. de la Cruz, Rex G. Fernandez, Fred C. Gamayao and Nelly S. Rentoy.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 13-2014 of the Municipality of Sibunag, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 13-2014 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

- 1. The Municipality has to observe the Personal Services cap pursuant to Section 325 (a) of RA 7160 and Local Budget Circular No. 98 dated October 14, 2011.*
- 2. The 5% Calamity Fund now known as the Local Disaster Risk Reduction Management Fund shall be utilized solely for the expenditures authorized under RA 10121, its implementing Rules and Regulations, DILG Memorandum Circular No. 2012-73 and COA Circular No. 2012-01.*

3. *The projects funded under the 20% Development Fund shall be subject to the provisions of the DILG-DBM Joint Memorandum Circular No. 2011-1 dated April 13, 2011.*
4. *The items of appropriations mainstreamed in the General Fund for GAD Plans, programs and projects shall be subject to Local Budget Memorandum (LBM) No. 36 dated July 4, 2001 and Joint DBM/NEDA/NCRFW Circular No. 2004-1.*
5. *The allocation of at least 1% of the LGU's total budget for plans, programs and services that address the needs of older persons and persons with disabilities shall be in accordance with DBM-DSWD Joint Circular No. 2003-01 dated April 28, 2003.*
6. *The utilization of funds for intelligence and Confidential Expenses shall be in accordance with DILG Memorandum Circular No. 99-65 dated 23 April 1999 and Memorandum Circular No. 99-10 dated June 15, 1999.*
7. *The appropriation for the LGU's counterpart to the Grassroots Participatory Budget Process formerly called Bottom-up Budgeting (BuB) projects shall be in accordance with the provisions of JMC No. 2 series of 2012 of DBM-DILG-DSWD-NAPC dated December 19, 2012.*

RESOLVED FURTHER, to require the Municipality of Sibunag to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to inform the Municipality of Sibunag that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.


