RESOLUTION NO. 09

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2014-05 OF THE MUNICIPALITY OF SAN LORENZO, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2014-05 of the Municipality of San Lorenzo authorizing its Supplemental Budget No. 05, Calendar Year 2014 involving an appropriation of One Million Seven Hundred Forty Three Thousand Three Hundred Pesos (₱1,743,300.00)was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS. subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance:

NOW THEREFORE, on motion of SP Member John Edward G. Gando, unanimously seconded.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2014-05 of the Municipality of San Lorenzo, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 2014-05 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

- 1. The disbursement of funds for the Productivity Enhancement Incentive (PEI) shall be in accordance with the provisions of DBM Budget Circular No. 2014-3 dated December 2, 2014.
- 2. The disbursement of funds for this Supplemental Budget shall not exceed the amount authorized in the Appropriation Ordinance.

RESOLVED FURTHER, to require the Municipality of San Lorenzo to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to inform the Municipality of San Lorenzo that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of San Lorenzo, for information.
