**RESOLUTION NO. 11**

**RESOLUTION RECOGNIZING AND COMMENDING THE VALIANT MEN AND WOMEN OF THE PHILIPPINE NATIONAL POLICE OF GUIMARAS FOR THEIR OUTSTANDING AND UNPARALLELED SERVICE DURING THE PAPAL VISIT**

*WHEREAS, the country has once again captured the center stage of the world, not because of another catastrophe, but because of the fact that the pillar of Catholic faith and a head of state, His Holiness Jorge Mario Bergoglio, popularly known as Pope Francis, has chosen to visit the Philippines primarily to comfort the Filipinos devastated by the typhoon and earthquake that hit Visayas under the banner of "mercy and compassion";*

*WHEREAS, his presence in our humble country from January 15-19, 2015, had virtually stopped the world from turning and had mesmerized Christians and Non-Christians alike;*

*WHEREAS, their collective effort, along with that of other concerned individuals, had brought Pope Francis safely to his home;*




