RESOLUTION NO. 12

RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 256, SERIES OF 2014 OF THE MUNICIPALITY OF BUENAVISTA, DENOMINATED AS “AN ORDINANCE ESTABLISHING A MARINE SANCTUARY IN THE MUNICIPAL WATERS OF BUENAVISTA” AS VALID AND WITHIN THE POWERS OF THAT SANGGUNIAN TO ENACT

WHEREAS, for review of this Honorable Body is Municipal Ordinance No. 256, Series of 2014 of the Municipality of Buenavista, denominated as “An Ordinance Establishing a Marine Sanctuary in the Municipal Waters of Buenavista”;

WHEREAS, said Municipal Ordinance No. 256 was referred to the Joint Committee on Rules and Privileges, Ordinances and Legal Matters and Committee on Agriculture;

WHEREAS, a committee hearing was conducted on January 8, 2015, inviting for the purpose, resource persons, authors of the ordinance and other technical people to help the committees in its appreciation;

WHEREAS, the joint committee, after having been apprised of the legal basis of that piece of legislation, rendered a committee report that was adopted by the Honorable Body in its session of even date, recommending that the subject ordinance be declared valid as it is within the powers of the Sangguniang Bayan of Buenavista to enact;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, unanimously seconded;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Municipal Ordinance No. 256, Series of 2014 of the Municipality of Buenavista, denominated as "An Ordinance Establishing a Marine Sanctuary in the Municipal Waters of Buenavista" as valid and within the powers of that Sanggunian to enact.


