APPROPRIATION ORDINANCE NO. 17
Series of 2016

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 04, CY 2016 INVOLVING THE AMOUNT OF TWO MILLION THREE HUNDRED TEN THOUSAND NINE HUNDRED TEN PESOS (₱2,310,910.00) TAKEN FROM THE INCOME DERIVED FROM THE REMAINING/EXCESS AMOUNT OF CLAIMS PAID BY PHILHEALTH TO DCGNPH FOR ITS MEMBERS FOR THE PERIOD MAY 01, 2016 TO JULY 31, 2016 TO BE APPROPRIATED FOR THE GENERAL SERVICES (5-02-12-990) IN THE AMOUNT OF TWO MILLION THREE HUNDRED TEN THOUSAND NINE HUNDRED TEN PESOS (₱2,310,910.00) AT THE DR. CATALINO GALLEGO NAVA PROVINCIAL HOSPITAL

Be it enacted in the Regular Session assembled:

Section 1. Supplemental Budget No. 04 of the Provincial Government of Guimaras for CY 2016 in the amount of Two Million Three Hundred Ten Thousand Nine Hundred Ten Pesos (₱2,310,910.00) taken from the income derived from the remaining/excess amount of claims paid by PHILHEALTH to DCGNPH for its members for the period May 01, 2016 to July 31, 2016 to be appropriated for the General Services (5-02-12-990) in the amount of Two Million Three Hundred Ten Thousand Nine Hundred Ten Pesos (₱2,310,910.00) of the Dr. Catalino Gallego Nava Provincial Hospital is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

1. Certification from the Provincial Treasurer as to fund availability.
2. Itemized funding allocation request from the Honorable Governor.

Section 2. Sources of Funds. The source of funds for Supplemental Budget No. 04 is as follows:

Income derived from the remaining/excess amount of Claims paid by PHILHEALTH to DCGNPH for its Members for the period May 01, 2016 to July 31, 2016-	₱2,310,910.00
Total Available for Appropriations	₱2,310,910.00

Section 3. Use of Funds. The amount of Two Million Three Ten Thousand Nine Hundred Ten Pesos (₱2,310,910.00) is hereby appropriated for Supplemental Budget No. 04, CY 2016 of the Dr. Catalino Gallego Nava Provincial Hospital (DCGNPH) for the General Services (5-02-12-990) in the amount of Two Million Three Hundred Ten Thousand Nine Hundred Ten Pesos (₱2,310,910.00)


Section 4. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 5. Effectivity. The provisions of this Ordinance shall take effect upon approval.




