Section 1. The amount of Sixty Six Thousand Eight Hundred Pesos (P66,800.00) is hereby realigned as follows:


From: Motor Vehicle Maintenance	-	P15,000.00

Section 2. This Appropriation Ordinance shall take effect upon its approval.




