AN ORDINANCE AMENDING SECTION 4, RULE 3, ORDINANCE NO. 01, SERIES OF 2006, ENTITLED: "AN ORDINANCE ADOPTING THE RULES OF PROCEDURE IN THE CONDUCT OF ADMINISTRATIVE INVESTIGATION AGAINST ELECTIVE MUNICIPAL OFFICIALS WITHIN THE PROVINCE OF GUIMARAS

Be it ordained by the Sangguniang Panlalawigan of the Province of Guimaras in its regular session assembled:

**Section 1.** Section 4. Rule 3. Ordinance No. 01. Series of 2006, entitled: "An Ordinance adopting the Rules of Procedures in the Conduct of Administrative Investigation Against Flective Municipal Officials Within the Province of Guimaras" is hereby amended to read as:

Section 4. Complaint filed with other agency- If a complaint is filed with another government agency, the same may be referred to and accepted by the Sanggunian, provided, it complies with all the requirements set forth in the immediately two (2) preceding sections, with the Secretary to the Sanggunian furnishing copy of the complaint to the Provincial Local Government Operations Officer (PLGOO), DILG-Guimaras.

**Section 2.** All ordinances inconsistent with the provisions of this ordinance are hereby repea ed and amended.
