**ORDINANCE RECOGNIZING THE “CAPITOL CHORALE” AS THE OFFICIAL CHORAL GROUP OF THE PROVINCIAL GOVERNMENT OF GUIMARAS AND PROVIDING FUNDS THEREFOR**

WHEREAS, the Provincial Government of Guimaras has been the host of several local, national and even international events thus, pursuing its track as the agri-tourism capital of the region;

WHEREAS, as the host, it is imperative that it shall showcase not only the natural and inherent beauty of the province but also the best talents of its human resources more particularly, the talents of the employees and officers of the provincial government;

WHEREAS, the present administration, thru Governor Samuel T. Gumarin and Board Member John Edward G. Gando, has initiated the formation of a choral group known as the “Capitol Chorale” to be participated by the employees and officers of the provincial government;

WHEREAS, the “Capitol Chorale” shall bring the name of the provincial government in official and public gatherings hosted or initiated by the provincial government;

WHEREAS, the “Capitol Chorale” is envisioned to be striving for the best to give a glimpse of the best of Guimarasnon’s spirit as it entertains and inspires various spectators and audiences;

WHEREAS, the collaboration of the employees and the management of the administration shall result to a harmonious and productive relationship among parties in realization of their respective obligations embodied in the Collective Negotiations Agreement (CNA) forged between the administration of the provincial government and the New Guimaras Provincial Employees Association (NGPEA);

**Section 2.** The Provincial Government shall endeavour to allocate funds for the expenditures of the Choral Group which shall be directly under the Office of the Governor.









**Section 3.** This Ordinance shall take effect upon approval.
