AN ORDINANCE CREATING THE POSITIONS OF PROJECT EVALUATION OFFICER III AT THE RESEARCH, MONITORING AND EVALUATION SECTION AND PLANNING OFFICER II AT THE PLANS AND PROGRAM SECTION IN THE PLANTILLA OF THE PROVINCIAL PLANNING AND DEVELOPMENT OFFICE (PPDO)

Be t ordained by the Sangguniang Panlalawigan of the Province of Guimaras in session assembled that:

Section 1. Title. This Ordinance shall be known as an Ordinance Creating the Positions of Project Evaluation Officer III at the Research, Monitoring and Evaluation Section and Planning Officer II at the Plans and Program Section in the Plantilla of the Provincial Planning and Development Office (PPDO)

Section 2. Objectives. The creation of the Positions of Project Evaluation Officer III at the Research.
