**AN ORDINANCE DEFUNDING THE 2017 BUDGET ALLOCATION FOR THE POSITION OF SPECIAL OPERATIONS OFFICER II (SOO II), ITEM NO. 321 AT THE OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (PSWDO) PLANTILLA IN THE AMOUNT OF ₱246,240.00, THE SAME TO BE DECLARED AS SAVINGS**

Whereas, the Honorable Governor, in his letter dated 23 January 2017, requested for favourable legislation to defund the budget allocation for the position of Special Operations Officer II (SOO II), Item No. 321 at the Provincial Social Welfare and Development Office (PSWDO) Plantilla in the amount of ₱246,240.00 to finance the position of Social Welfare Assistant (SWA) for CY 2017;

WHEREAS, upon deliberation and for lack of documents to show that the position of Social Welfare Assistant (SWA) is existing in that office, the Honorable Body decided that it shall only focus on the defunding of the SOO II;

NOW THEREFORE, on motion of Hon. David G. Gano, Chairperson, Committee on Appropriations, duly seconded by Hon. Aurelio G. Tionado and Hon. Ma. Sheila G. Gange;


Be it ordained by the 8<sup>th</sup> Sangguniang Panlalawigan of the Province of Guimaras in session assembled that:

**Section 2.** This Ordinance shall take effect upon approval.


