ORDINANCE NO. 2017-007

Series of 2017

AN ORDINANCE AMENDING SECTION 12 OF ORDINANCE NO. 2017-003 ENTITLED: "AN ORDINANCE REGULATING THE PRODUCTION, HARVESTING AND MARKETING OF GUIMARAS MANGO FRUITS"

Be it ordained by the 8^{th} Sangguniang Panlalawigan of the Province of Guimaras in its Regular Session duly assembled that:

Section 1. Section 12 of Ordinance No. 2017-003, Series of 2017 entitled: "An Ordinance Regulating the Production, Harvesting and Marketing of Guimaras Mango Fruits" is hereby amended to read as follows:

Section 12. Penal Clause- Any person found violating any provisions of this Ordinance shall be meted out with the following fines/penalties:

First Offense ------ ₱1,000.00 Second Offense ----- ₱2,000.00


Third Offense ------- \$\frac{1}{2}3,000.00 \text{ and/ or imprisonment of not to exceed one}


(1) month or both such fine and imprisonment at the discretion of the court.

Prior to filing of appropriate charges, any person found violating this Ordinance shall be issued a Citation Ticket in such a form as the Provincial Governor may device, commanding the offender to appear in the Office of the Governor within seventy two (72) hours from the issuance thereof to show cause why he/she should not be prosecuted for violation of this Ordinance. Within the said period of seventy two (72) hours, the respondent may elect to voluntarily pay the following fines in lieu of the prosecution:

First Offense -----₱1,000.00 Second Offense ----₱2,000.00

Third Offense ------₱3,000.00







- Section 2. Separability Clause- If any part or provision of this Ordinance shall be declared unconstitutional or unlawful by the court, or suspended or revoked by competent authorities, all other provisions not otherwise affected thereby shall remain valid and effective.
- Section 3. Repealing Clause- Any Ordinance contrary or inconsistent with any provisions of this Ordinance is hereby repealed, amended or modified accordingly.
 - Effectivity- This Ordinance shall take effect upon approval. Section 4.
