ORDINANCE NO. 2017-008

AN ORDINANCE ALTERING THE BOUNDARIES OF BARANGAY INAMPULOGAN AND EXTENDING THE SAME TO THE ISLAND SITIO OF NAOWAY OF BARANGAY SAN ISIDRO IN THE MUNICIPALITY OF SIBUNAG

Section 1. The boundaries of Barangay Inampulogan of the Municipality of Sibunag is hereby altered thereby extending the same to the island Sitio of Naoway which is used to be within the territorial boundaries of Barangay San Isidro in the Municipality of Sibunag. The said island sitio shall now form part of the political boundaries of Barangay Inampulogan for all legal intents and purposes. The seat of government of Barangay Inampulogan with its extended political boundaries shall be at Sitio Naoway;

Section 2. Within ninety (90) days after the approval of this Ordinance, a plebiscite shall be conducted in the barangays affected. The Commission on Elections shall conduct and supervise the plebiscite;

Section 3. Upon ratification of this ordinance by the majority of votes cast in the plebiscite, the election of barangay and SK officials in Barangay Inampulogan, Sibunag, Guimaras shall coincide with the next regular barangay and SK elections scheduled on October 23, 2017 or any other date provided by law as a result of any postponement thereto;

Section 4. The accumulated Internal Revenue Allotment (IRA) deposited at the Land Bank of the Philippines (LBP) and the share in Real Property Tax (RPT) including other funds of Barangay Inampulogan at the custody of the Municipal Treasurer shall be treated as Trust Fund to be utilized for: the development projects for the period of five (5) years, the immediate capacity development program of newly

elected and appointed barangay officials in the amount of One Hundred Thousand Pesos (Php 100,000.00) and an additional allocation for administrative and maintenance /operating cost of not more than four percent (4%) of the trust amount of the development projects per year for the next five (5) years following the first election of Barangay Officials. For this purpose, a 5-year Barangay Development Plan (BDP) and corresponding Local Development and Investment Program (LDIP) shall be prepared by the Barangay Development Council and duly approved by the Sangguniang Barangay utilizing the trust fund prorated for 5 years plus the estimated 20% development fund from the IRA share and other fund sources for each year. The Annual Investment Program (AIP) shall be prepared for yearly implementation of priority projects and other budgetary requirements.

Section 5. The Municipal Mayor shall ensure that the Local Special Bodies and Barangay Based Institutions pursuant to the Local Government Code, DILG Memorandum Circulars and other laws and issuances shall be organized with the mandated CSO/NGO representation that will be involved in planning, implementation and monitoring of programs and projects in the barangay. The sectoral concerns as mandated by laws such as the Youth (SK), Disaster Risk Reduction Management (DRRM), Gender and Development (GAD), Senior Citizen, Person with Disabilities (PWD), Children, etc., shall be included in the BDP and LDIP of the barangay. The Sangguniang Barangay shall ensure that infrastructure projects shall be constructed at barangay owned or donated lots.

Section 6. The barangay shall operate on an annual budget starting CY 2018 pursuant to the provisions of RA 7160, Budget Circulars of the Department of Budget and Management (DBM) and Guidelines of the Commission on Audit. The honoraria of Barangay Officials of Inampulogan for December 2017 shall not be more than fifty five (55%) percent of the Barangay IRA for December 2017. Ten (10) percent shall be allotted for the Maintenance and Other Operating Expenses (MOOE) of the barangay for the same period. The Municipal Budget Officer of the Municipality of Sibunag shall provide proper guidance on the equitable distribution of the honoraria of barangay officials for the last month of CY 2017. The remaining amount of the CY 2017 IRA and other fund sources due to barangay Inampulogan shall be incorporated in the Trust Fund.

Section 7. Should the 2017 Barangay and SK elections be moved to some other dates, the mechanism as expressed in Sections 4 and 6 hereof on the allocation and utilization of funds shall be observed.

Section 8. The necessary allocation to cover the expenses that may be incurred on the conduct of the plebiscite shall be shared by the Municipality of Sibunag and the Province of Guimaras.


Section 9. Separability Clause- If any part or provision of this Ordinance shall be declared unconstitutional or unlawful by the court, or suspended or revoked by competent authorities, all other provisions not otherwise affected thereby shall remain valid and effective.

Section 10. Repealing Clause- Any Ordinance contrary or inconsistent with any provisions of this Ordinance is hereby repealed, amended or modified accordingly.



Section 11. Effectivity- This Ordinance shall take effect upon approval.


