## APPROPRIATION ORDINANCE NO. 01

Series of 2017

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01, CY 2017 INVOLVING THE AMOUNT OF FORTY ONE MILLION FIVE HUNDRED TWENTY THOUSAND THREE HUNDRED FORTY ONE PESOS AND FORTY THREE CENTAVOS (\*\*P41,520,341.43) TAKEN FROM THE EQUITY AVAILABLE FOR OPERATIONS (2016) IN THE AMOUNT OF FIFTY THREE MILLION EIGHT HUNDRED NINETY TWO THOUSAND TWO HUNDRED FORTY THREE PESOS AND SEVEN CENTAVOS (\*\*P53,892,243.07) TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT OF GUIMARAS

Be it enacted in the Regular Session assembled:

Section 1. Supplemental Budget No. 01 of the Provincial Government of Guimaras for CY 2017 in the amount of Forty One Million Five Hundred Twenty Thousand Three Hundred Forty One Pesos and Forty Three Centavos (₱41,520,341.43) taken from the Equity Available for Operations (2016) in the amount of Fifty Three Million Eight Hundred Ninety Two Thousand Two Hundred Forty Three Pesos and Seven Centavos (₱53,892,243.07) is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

- 1. Certification from the Provincial Treasurer as to fund availability.
- 2. Itemized funding allocation request from the Honorable Governor.

**Section 2.** Sources of Funds. The source of funds for Supplemental Budget No. 01 is as follows:
