"AN ORDINANCE AMENDING SECTION 3, ITEM NO. 9 OF THE "EXPENDITURES" OF APPROPRIATION ORDINANCE NO. 01, CY 2017 ENTITLED: "AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01, CY 2017 INVOLVING THE AMOUNT OF FORTY ONE MILLION FIVE HUNDRED TWENTY THOUSAND THREE HUNDRED FORTY ONE PESOS AND FORTY THREE CENTAVOS (\$\frac{P}{4}1,520,341.43)\$ TAKEN FROM THE EQUITY AVAILABLE FOR OPERATIONS (2016) IN THE AMOUNT OF FIFTY THREE MILLION EIGHT HUNDRED NINETY TWO THOUSAND TWO HUNDRED FORTY THREE PESOS AND SEVEN CENTAVOS (\$\frac{P}{5}3,892,243.07)\$ TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT OF GUIMARAS"

Be it enacted by the 8th Sangguniang Panlalawigan of the Province of Guimaras in its Regular Session duly assembled that:

Section 1. Section 3, Item No. 9 of the "Expenditures" of Appropriation Ordinance No. 01, CY 2017 entitled: "An Ordinance authorizing Supplemental Budget No. 01, Cy 2017 involving the amount of Forty One Million Five Hundred Twenty Thousand Three Hundred Forty One Pesos and Forty Three Centavos (₱41,520,341.43) taken from the Equity Available for Operations (2016) in the amount of Fifty Three Million Eight Hundred Ninety Two Thousand Two Hundred Forty Three Pesos and Seven Centavos (₱53,892,243.07) to cover various expenditures of the Provincial Government of Guimaras" is hereby amended to read as follows:
