AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01, CY 2017 INVOLVING THE AMOUNT OF EIGHTY EIGHT THOUSAND SIX HUNDRED FIFTY PESOS (P88,650.00) TAKEN FROM UNAPPROPRIATED SURPLUS CY 2016 OF DR. CATALINO GALLEGO NAVA PROVINCIAL HOSPITAL (DCGNPH) IN THE AMOUNT OF FIFTEEN MILLION ONE HUNDRED FIFTY NINE THOUSAND SIX HUNDRED NINETY THREE PESOS AND FIFTY FOUR CENTAVOS (₱15,159,693,54) TO COVER VARIOUS EXPENDITURES OF THE DR. CATALINO GALLEGO NAVA PROVINCIAL HOSPITAL (DCGNPH)

Be it enacted in the Regular Session assembled:

Section 1. The Supplemental Budget of the Dr. Catalino Gallego Nava Provincial Hospital for CY 2016 in the total amount of Eighty Eight Thousand Six Hundred Fifty Pesos (₱88,650.00) taken from the Un-appropriated Surplus CY 2016 of DCGNPH to cover various expenditures is hereby approved.
