**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 04, CY 2017 INVOLVING THE AMOUNT OF SEVEN MILLION THREE HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED EIGHT PESOS (P7,324,208.00) TAKEN FROM THE LAND BANK OF THE PHILIPPINES-RELEASE FOR HOSPITAL EQUIPMENT PER PN#9651-LT17-0007-044 DATED 09/27/2017 IN THE AMOUNT OF SEVEN MILLION THREE HUNDRED TWENTY FOUR THOUSAND TWO HUNDRED EIGHT PESOS (P7,324,208.00) TO PAYMENT OF HOSPITAL EQUIPMENT**

Be it enacted in the Regular Session assembled:

**Section 1.** Supplemental Budget No. 04 of the Provincial Government of Guimaras for CY 2017 in the amount of Seven Million Three Hundred Twenty Four Thousand Two Hundred Eight Pesos (P7,324,208.00) taken from the Land Bank of the Philippines-Release for Hospital Equipment per PN#9651-LT17-0007-044 dated 09/27/2017 in the amount of Seven Million Three Hundred Twenty Four Thousand Two Hundred Eight Pesos (P7,324,208.00) to payment of hospital equipment is hereby approved.

**Section 5.** Effectivity. The provisions of this Ordinance shall take effect upon approval.


