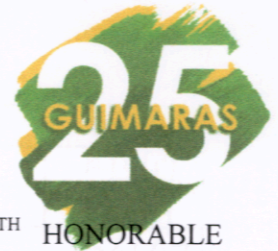



**Section 2.** This Appropriation Ordinance shall take effect upon its approval.


