RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 257, SERIES OF 2014 OF THE MUNICIPALITY OF BUENAVISTA, ENTITLED: "AN ORDINANCE PROHIBITING THE SALE, DISTRIBUTION AND USE OF FIRECRACKERS AND OTHER TYPES OF EXPLOSIVE DEVICES TO MINORS IN THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS", AS VALID AND WITHIN THE POWERS OF THAT SANGGUNIANG BAYAN TO ENACT

WHEREAS, for review of this Honorable Body is Municipal Ordinance No. 257, Series of 2014 of the Municipality of Buenavista, entitled: "An Ordinance Prohibiting the Sale, Distribution and Use of Firecrackers and Other Types of Explosive Devices to Minors in the Municipality of Buenavista, Province of Guimaras";

WHEREAS, the Joint Committee on Rules and Privileges, Ordinance and Legal Matters and Committee on Peace and Order to where Ordinance No. 257 was referred, conducted a Committee Hearing that came out with a committee report that recommends for some corrections in so far as the penalties to the maximum amount of P2.5000.00:
