**RESOLUTION NO. 22**

***RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH, TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS, THE CONTRACT OF UNDERTAKING WITH DR. GENEVIEVE L. ROMULO FOR A STUDY LEAVE EFFECTIVE FEBRUARY 19, 2015 TO MARCH 25, 2015***

*WHEREAS, for the consideration of this Honorable Body is a request of the Honorable Governor for an authority to sign for and in behalf of the Provincial Government of Guimaras, the Contract of Undertaking with Dr. Genevieve L. Romulo to undertake a study leave for the latter to take the Diplomate Examination given by the Philippine Pediatric Society;*

*WHEREAS, said request was referred to the Joint Committee on Health and Committee on Good Government that submitted a Committee Report recommending for the grant of the request to take effect on February 19, 2015;*

*WHEREAS, this Honorable Body, finding the same to be in order, interposes no objection to grant the authority to the Honorable Governor;*

*NOW, THEREFORE, on motion of Hon. Josephina de la Cruz, unanimously seconded;*

***THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:***

*RESOLVED, to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf the Provincial Government of Guimaras, the following:*

#### **CONTRACT OF UNDERTAKING**

This CONTRACT OF UNDERTAKING entered into by and between the Office of the Governor, Province of Guimaras, represented herein by the Provincial Governor HON. SAMUEL T. GUMAIRN, MD, MPH, hereinafter referred to as AGENCY HEAD and DR. GENEVIEVE L. ROMULO of legal age, married, and a resident of Barangay Buluangan, Jordan, Guimaras, Philippines and a permanent employee in NUEVA VALENCIA and detailed at DR. CATALINO GALLEGOS NAVA PROVINCIAL HOSPITAL holding the position of Medical Officer IV, hereinafter referred to as the BENEFICIARY.

#### **WITNESSETH:**

WHEREAS, the Agency Head has approved the application of the Beneficiary for a Study Leave as based on Omnibus Rules on Leave Rule XVI of the Omnibus Rules Implementing Book V of EO 292, as amended by Civil Service Resolution No. 041016 (SCS MC No. 21, S. 2004) for the study leave from February 19, 2015 to March 25, 2015.

WHEREAS, the office has allowed the BENEFICIARY to undertake an official study leave for one (1) month and 6 days effective from February 19, 2015 to March 25, 2015.

NOW THEREFORE, in consideration of the foregoing premises, the parties hereby agree as follows:

#### **A. The Agency Head**

1. The Agency Head authorize the Beneficiary to take Diplomate Examination of Philippine Pediatric Society at Manila, Philippines on official time covering from February 19, 2015 to March 25, 2015.
2. The Agency Head authorizes the Beneficiary to draw her salaries, fringe benefits and allowances due to her during the period stated herein pursuant to existing laws, rules and regulations and guidelines applicable under the circumstances.
3. The Agency Head shall terminate this Contract of Undertaking upon proof that the Beneficiary has not complied with her obligations as stated in the Contract. In such event, the Agency Head shall require the Beneficiary to comply with her obligations stated herein.

#### **B. The Beneficiary**

1. The Beneficiary shall take Diplomate Examination of Philippine Pediatric Society.
2. The services of the Beneficiary during the period covered maybe dispensed with.
3. The Beneficiary shall observe the following terms and conditions as what is being stipulated on Sec. 68 Memorandum Circular No. 14, S. 1999, as amended by the Civil Service Commission Resolution No. 041016 (CSC MC No. 21, S. 2004). (Kindly refer attached Annex "A").

#### **C. Effectivity**

1. This Contract shall be in force and effect upon approval hereof.


