APPROPRIATION ORDINANCE NO. 23

Series of 2016

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 07, CY 2016 INVOLVING THE AMOUNT OF TWO MILLION NINE HUNDRED FOURTEEN THOUSAND EIGHT HUNDRED THIRTY TWO PESOS AND THREE CENTAVOS (₱2,914,832.03) TAKEN FROM THE TERMINAL LEAVE IN THE AMOUNT OF ONE MILLION NINE HUNDRED FORTY SIX THOUSAND FOUR HUNDRED THIRTY TWO PESOS AND THREE CENTAVOS (₱1,946,432.03) AND LAND BANK OF THE PHILIPPINES-LOAN RELEASE FOR HOSPITAL EQUIPMENT IN THE AMOUNT OF NINE HUNDRED SIXTY EIGHT THOUSAND FOUR HUNDRED PESOS (₱968,400.00) TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT OF GUIMARAS

Be it enacted in the Regular Session assembled:

Section 1. Supplemental Budget No. 07 of the Provincial Government of Guimaras for CY 2016 in the amount of Two Million Nine Hundred Fourteen Thousand Eight Hundred Thirty Two Pesos and Three Centavos (\$\frac{1}{2}\$,914,832.03) taken from the Terminal Leave in the amount of One Million Nine Hundred Forty Six Thousand Four Hundred Thirty Two Pesos and Three Centavos (\$\frac{1}{2}\$,946,432.03) and Land Bank of the Philippines-Loan Release for Hospital Equipment in the amount of Nine Hundred Sixty Eight Thousand Four Hundred Pesos (\$\frac{1}{2}\$968,400.00) to cover various expenditures of the Provincial Government of Guimaras is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this ordinance:

- 1. Certification from the Provincial Treasurer as to fund availability.
- 2. Itemized funding allocation request from the Honorable Governor.

Section 2. <u>Sources of Funds.</u> The source of funds for Supplemental Budget No. 07 is as follows:

Section 3. <u>Use of Funds</u>. The amount of Two Million Nine Hundred Fourteen Thousand Eight Hundred Thirty Two Pesos and Three Centavos (₱2,914,832.03 is hereby appropriated for Supplemental Budget No. 07, CY 2016 of the Provincial Government of Guimaras, as follows:
