RESOLUTION NO. 24

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 006, SERIES OF 2014, APPROVING THE ANNUAL PERFORMANCE BUDGET FOR FY 2015 OF THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 006, Series of 2014 of the Municipality of Buenavista authorizing its 2015 Annual Executive Budget involving an appropriation of Ninety Two Million Five Hundred Nine Thousand Pesos (P92,509,000.00) for the General Fund and Eight Million One Thousand Pesos (P8,001,000.00) for the Municipal Economic Enterprise was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, duly seconded by SP Member Josefina G. de la Cruz.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 006, Series of 2014 of the Municipality of Buenavista, Province of Guimaras as operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 006, Series of 2014 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

- 1. Projects funded under the 2015 20% Development Fund shall be subject to the provisions of the DILG-DBM Joint Memorandum Circular No. 2011-1 dated April 13, 2011.*
- 2. The 5% Calamity Fund now known as the Local Disaster Risk Reduction Management Fund shall be utilized solely for the expenditures authorized under RA 10121, its implementing Rules and Regulations, NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 and DILG Memorandum Circular No. 2012-73 and COA Circular No. 2012-01.*

3. Fund utilization for intelligence and Confidential Expenses shall be in accordance with the DILG Memorandum Circular No. 99-65 dated 23 April 1999 and Memorandum Circular No. 99-100 dated June 15, 1999.
4. Items of appropriations mainstreamed/subsumed in the General Fund that specify for GAD Plans, programs and projects shall be subject to Local Budget Memorandum No. 36 dated July 4, 2001 and Joint DBM/NEDA/NCRFW Circular No. 2004-1.
5. The allocation of at least 1% of the LGU's total budget plans, programs and services that address the needs of older persons and persons with disabilities shall be in accordance with DBM-DSWD Joint Circular No. 2003-01 dated 28 April 2003.
6. The Municipality has to observe the Personal Services cap pursuant to Section 325 (a) of R.A. 7160 and Local Budget Circular No. 98 dated October 14, 2011.

RESOLVED FURTHER, to require the Municipality of Buenavista to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of Buenavista that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Buenavista, for information.
