APPROPRIATION ORDINANCE NO. 28

AN ORDINANCE REVERTING THE TOTAL AMOUNT OF THREE MILLION SIX HUNDRED ELEVEN THOUSAND ONE HUNDRED SEVENTY FIVE PESOS AND FIFTY TWO CENTAVOS (\$\frac{1}{2}3,611,175.52)\$ TAKEN FROM SAVINGS FROM COMPLETED 20% DEVELOPMENT FUND PROJECTS IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED ELEVEN THOUSAND ONE HUNDRED SEVENTY FIVE PESOS AND FIFTY TWO CENTAVOS (\$\frac{1}{2}2,811,175.52)\$ AND FROM THE UNIMPLEMENTED PROJECTS OF THE 20% DEVELOPMENT FUND IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (\$\frac{1}{2}800,000.00)\$ TO THE GENERAL FUND (2017 20% DEVELOPMENT FUND)

Be it enacted by the Honorable 8th Sangguniang Panlalawigan of the Province of Guimaras in its regular session duly assembled that:

Section 1. The total amount of Three Million Six Hundred Eleven Thousand One Hundred Seventy Five Pesos and Fifty Two Centavos (₱3,611,175.52) is hereby reverted as follows:
