APPROPRIATION ORDINANCE NO. 28

AN ORDINANCE REVERTING THE TOTAL AMOUNT OF THREE MILLION SIX HUNDRED ELEVEN THOUSAND ONE HUNDRED SEVENTY FIVE PESOS AND FIFTY TWO CENTAVOS (P3,611,175.52) TAKEN FROM SAVINGS FROM COMPLETED 20% DEVELOPMENT FUND PROJECTS IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED ELEVEN THOUSAND ONE HUNDRED SEVENTY FIVE PESOS AND FIFTY TWO CENTAVOS (P2,811,175.52) AND FROM THE UNIMPLEMENTED PROJECTS OF THE 20% DEVELOPMENT FUND IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (P800,000.00) TO THE GENERAL FUND (2017 20% DEVELOPMENT FUND)

Be it enacted by the Honorable 8th Sangguniang Panlalawigan of the Province of Guimaras in its regular session duly assembled that:

Section 1. The total amount of Three Million Six Hundred Eleven Thousand One Hundred Seventy Five Pesos and Fifty Two Centavos (P3,611,175.52) is hereby reverted as follows:

Section 2. This Appropriation Ordinance shall take effect upon its approval.




