APPROPRIATION ORDINANCE NO. 35
Series of 2016

AN ORDINANCE AUTHORIZING THE 2017 ANNUAL EXECUTIVE BUDGET FOR THE LOCAL ECONOMIC ENTERPRISE OF THE PROVINCE OF GUIMARAS IN THE AMOUNT OF SEVENTY SEVEN MILLION THREE HUNDRED FIFTY FOUR THOUSAND SEVEN HUNDRED TWENTY SEVEN PESOS (P77,354,727.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE DR. CATALINO GALLEGO NAVA PROVINCIAL HOSPITAL FOR FISCAL YEAR 2017 AND APPROPRIATING THE NECESSARY FUND FOR THE PURPOSE

Be it enacted by the Sangguniang Panlalawigan of the Province of Guimaras in the regular session assembled:

Section 1. The 2017 Annual Executive Budget for the Local Economic Enterprise of the Province of Guimaras in the amount of Seventy Seven Million Three Hundred Fifty Four Thousand Seven Hundred Twenty Seven Pesos (P77,354,727.00) covering the various expenditures for the operation of the Dr. Catalino Gallego Nava Provincial Hospital (DCGNPH) for Fiscal Year 2017 is hereby approved.

Section 2. The duly adopted Committee Report presented last December 20, 2016 by the Committee on Appropriations and the Sponsorship Speech of the Chairperson shall form an integral part of this Appropriation Ordinance.




Section 6. Effectivity Clause. This appropriation ordinance shall take effect on January 1, 2017.
