**AN ORDER RECONSTITUTING THE BIDS AND AWARDS COMMITTEE (BAC)
OF THE PROVINCE OF GUIMARAS**

WHEREAS, Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act" or GPRA was created for the purpose of prescribing the necessary rules and regulations for the modernization, standardization, and regulation of the procurement activities of the Government of the Philippines (GOP);

WHEREAS, Section 11 of the R.A. 9184 provides that each Procuring Entity shall establish a single BAC for its procurement. The BAC shall have at least five (5) members, but not more than seven (7) members;

WHEREAS, to strengthen and promote the professionalization of the organization organic office that carries out the procurement function, it is but ideal to designate the Head Secretariat of the Bids and Awards Committee;

NOW THEREFORE, I, SAMUEL T. GUMARIN MD., MPH, Governor, Province of Guimaras by virtue of the powers vested upon me by law, rules, regulations and decrees duly promulgated by competent authority, do hereby reconstitute the Bids and Awards Committee (BAC) in the Province of Guimaras with the following composition:

Section 1. BAC Membership. The members of the Bids and Awards Committee (BAC) shall be composed of the following:

Section 2. BAC Secretariat Membership. The BAC Secretariat shall be composed of personnel from the Provincial General Services Office and the Provincial Legal Office namely:
