**EXECUTIVE ORDER REORGANIZING THE PROVINCIAL COUNCIL FOR THE PROTECTION OF CHILDREN (PCPC) INCORPORATING THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COORDINATING COMMITTEE, AND REDEFINING THE LINK BETWEEN THE PCPC AND THE PROVINCIAL ADVISORY COMMITTEE (PAC) OF THE PANTAWID PAMILYANG PILIPINO PROGRAM, THE INTER-AGENCY MONITORING TASK FORCE (IMTF), AND THE PROVINCIAL NUTRITION COMMITTEE (PNC)**

**WHEREAS**, Executive Order No. 21, Series of 2013 was issued last 29 July 2013 reorganizing the PCPC incorporating the ECCD Coordinating Committee;

**WHEREAS**, Executive Order No. 20, Series of 2013 was also issued last 29 July 2013 organizing the PAC and the Grievance Committee relative to the implementation of the Pantawid Pamilyang Pilipino Program which addresses children's concerns particularly on their survival and development rights;

**WHEREAS**, DILG Memorandum Circular No. 2008-126 mandates that there shall be an IMTF in every level (municipal, city, provincial) to monitor and evaluate the functionality of the LCPC in accordance with its prescribed guidelines and evaluation tool;

**WHEREAS**, there is also a need to strengthen linkage between the PCPC and the PNC in addressing concerns on malnutrition among children, pregnant women and lactating mothers;

**WHEREAS**, some of the PCPC members are no longer connected with the Provincial Government or the identified member-agencies/organizations due to retirement/transfer of office/reorganization of officers of the identified partner-organizations, or had not attended any of the council's regular meetings since January 2015;

**WHEREAS**, based on the above-mentioned premises, there is a need to reorganize the PCPC and redefine the linkage between the PCPC and the various committees working for the benefit of children in the province;

**NOW, THEREFORE, I, SAMUEL T. GUMARIN, MD, MPH**, Governor, Province of Guimaras, do hereby reorganize the PCPC incorporating ECCD Coordinating Committee, and redefining the link between the PCPC and the PAC of the Pantawid Pamilyang Pilipino Program, the IMTF, and the PNC.

**Section 2.** The **PCPC** shall have the following specific functions:

1. Formulate plans, programs and policies for children that are gender-fair, culturally relevant and responsive to the needs of diverse groups of children from 0 to below 18 years of age;
2. Prepare Annual Work and Financial Plan (AWFP) for children and recommend appropriations to the Sanggunian;
3. Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
4. Provide technical assistance and recommend financial support to the Municipal and Barangay Councils for the Protection of Children;
5. Establish and maintain database on children in the province;
6. Advocate and recommend local legislations promoting child survival, protection, participation and development, especially on the quality of television shows and media prints and coverage, which are detrimental to children, and with appropriate funding support;
7. Conduct capability building programs to enhance knowledge and skills in handling children's program;
8. Monitor and evaluate the implementation of program and submit quarterly status reports to the Regional Sub-Committee for the Welfare of Children (RSCWC);
9. Perform such other functions as provided for in the ECCD and other child related laws.
10. Report on Program implementation concerns/updates during the quarterly PCPC meetings.

**Section 3.** The **PAC** of the Pantawid Pamilyang Pilipino Program and the **PNC** shall be considered as Committees under the PCPC.

**Section 4.** The **PAC** shall be composed of the regular or alternate members of the PCPC from the following offices with the head of the **PSWDO** as the **Vice Chair** and **designated representative of the PAC in the Regional Advisory Committee**:

DOH (Guimaras Provincial Health Team)  
DepEd  
DILG  
NCIP  
DSWD

**Section 5.** In fulfilling the commitments of the Provincial Government as stipulated in the signed Memorandum of Agreement (MOA) with the DSWD, **the PAC** in general, shall be tasked to oversee the over-all implementation of the Pantawid Pamilyang Pilipino Program in the province with the following specific functions:

1. Assist in facilitating the submission of Supply Side Assessment;
2. Monitor the availability of required supplies services and logistical support;
3. Recommend to the Provincial Government the provision of augmentation/logistical support to the municipalities particularly on health and education and the enrollment of the beneficiaries to Philhealth;
4. Ensure that the required support to the municipalities is covered by appropriate fund support in the annual budget;
5. Monitor the compliance of the municipalities in the submission of reports verification forms, grievance and redress and other reporting requirements;
6. Provide technical assistance to municipal counterparts in the provision of support services and programs such as value formation and education, livelihood assistance, health sanitation and organization and neighborhood groups;
7. Shall act on queries and complaints on non-compliance to Pantawid Pamilyas conditionalities elevated to the province for appropriate action;
8. Refer to the Regional Advisory Committee all concerns needing higher level intervention or resolution;
9. Assign a member to sit as representative of the province in Pantawid Regional Advisory Committee.

**Section 6.** The **IMTF** shall be composed of the regular members/alternates of the PCPC consisting of the following offices with **DILG Provincial Director or designated Provincial Focal Person as the Chairperson** and the following as members:

**Section 7.** It shall be the responsibility of the **IMTF** to conduct quarterly monitoring of the functionality of the MCPC and provide necessary technical assistance to the MCPCs and share monitoring results and relevant recommendations to the PCPC in order to sustain/ensure achievement of the ideal level of functionality of the MCPCs in the province.

**Section 8.** Secretariat support to the PCPC, PAC and IMTF shall be provided by the PSWDO.

**Section 9.** The **PNC** as a committee under the PCPC, in addition to its functions as specified in EO no. 30, Series of 2014 shall be responsible in the formulation of its annual Action Plan and shall present the said plan to the PCPC for approval. It shall also be responsible in monitoring functionality of and providing the needed technical assistance to the Municipal Nutrition Committees, and in reporting updates to the PCPC during its quarterly meetings.

This order shall take effect immediately.

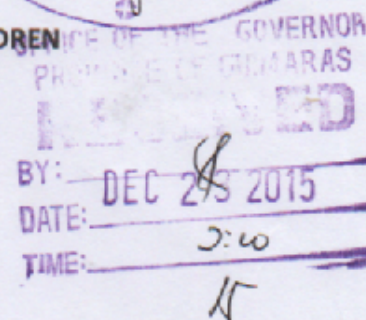
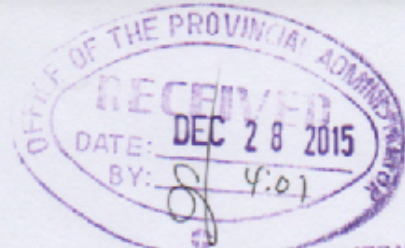
