EXECUTIVE ORDER: NO. 47

AN ORDER REORGANIZING THE PROVINCIAL HEALTH BOARD, PROVINCE OF GUIMARAS

WHEREAS, Section 102 of the Local Government Code of 1991 mandates Local Government Units to create the Local Health Board to cater to the well-being and promote health safety for its inhabitants;

WHEREAS, there is a need to reorganize the Provincial Health Board in the Province of Guimaras in view of the accreditation of the Civil Society Organizations by the new sets of Sangguniang Panlalawigan;

WHEREAS, Civil Society Organization Representatives have met and elect from among themselves their representative`.

NOW THEREFORE, I, SAMUEL T. GUMARIN, MD., MPH., Governor, Province of Guimaras by virtue of the powers vested upon me by law, rules, regulations and decrees duly promulgated by competent authority, do hereby reconstitute, the Provincial Health Board, Province of Guimaras.

Section 1. composition. The Provincial Health Board in the Province of Guimaras is hereby reorganized to be composed of the following:

Section 2. The function of the Provincial Health Board:

1. Propose to the Sanggunian concerned, in accordance with the standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the province;
2. Serve as an advisory committee to the Sanggunian concerned on the health matters such as, but not limited to, the necessity for, and application of local appropriation for public health purposes; and

3. Create committee and/or technical working groups (TWGs) which shall advise local health agencies on matters such as but not limited to technical and administrative standards of the Department of Health, personnel selection and promotion, bids and awards grievance and complaints, personnel discipline, budget review and similar functions.

Section 3. Meetings and Quorum.

The board shall meet at least once a month or as often as may be necessary. A majority of the members of the Board shall constitute a quorum, but the chairman or the vice chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all majority of the members shall be necessary to approve such proposals.

Section 4. Secretariat.

There shall be a Secretariat of at least two (2) personnel from the Provincial Health Office as designated by the Board.

This Order shall take effect immediately.
