AN ORDER REORGANIZING THE PROVINCIAL SCHOOL BOARD IN THE PROVINCE OF GUIMARAS

WHEREAS, Executive Order No. 42 Series of 2016 was issued reorganizing the Provincial School Board in the Province of Guimaras;

WHEREAS, Section 98 of the Local Government Code of 1991 provides for the establishment of a Local School Board in every province, city and municipality of the country;

WHEREAS, one of the members of the PSB has transferred to a national agency and one of the secretariat was reassigned as head of office;

WHEREAS, there is a need for a replacement of the said members to complete the composition of the Local School Board in the Province of Guimaras, thereby reorganization is necessary;

NOW THEREFORE, I, SAMUEL T. GUMARIN MD., MPH, Governor, Province of Guimaras by virtue of the powers vested upon me by law, rules, regulations and decrees duly promulgated by competent authority, do hereby order the following;

Section 1. Composition of the Provincial School Board in the Province of Guimaras is hereby reorganized to be composed of the following:

Section 2. The function of the Provincial School Board:

- Determine, in accordance with the criteria set by the Department of Education, the
 annual supplementary budgetary needs for the operation and maintenance of public
 school within the province and the supplementary local cost of meeting such needs,
 which shall be reflected in the form of an annual school board budget corresponding to
 its share in the proceeds of the special levy on real property constituting the Special
 Education Fund and such other sources of revenue as this Code and other laws or
 ordinances may provide.
- Authorize the Provincial Treasurer to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with existing rules and regulations;
- Serve as an advisory committee to the Sangguniang Panlalawigan on educational matters such as, but not limited to, the necessity for and the uses of local appropriations for educational purposes; and
- Recommend changes in the names of public schools in the Province of Guimaras for enactment by the Sangguniang Panlalawigan.

This order shall take effect immediately.
