WHEREAS, this Honorable Body is in receipt of PDC Resolution No. 30, Series of 2014 entitled: Resolution requesting the Sangguniang Panlalawigan to endorse to the Regional Development Council (RDC) VI and the National Government, the proposed bridge connecting Panay-Guimaras-Negros;
