**RESOLUTION NO. 32**

***RESOLUTION FAVORABLY ENDORSING TO THE MARITIME INDUSTRY AUTHORITY (MARINA), THE PROPOSAL OF FF CRUZ AND COMPANY, INC. FOR RORO OPERATIONS USING THE LANDING CRAFT TRANSPORT (LCT) FROM PORT OF SIBUNAG TO PORT OF PULUPANDAN AND VICE VERSA***

*WHEREAS, this Honorable Body was informed that the Montenegro Shipping Lines that has been operating from Sibunag Port to Pulupandan Port and vice versa has stopped its operation due to some destructions at the Sebaste, Sibunag Port;*

*WHEREAS, Guimarasnons who have been engaging the services of the Montenegro Roro facility, especially the businessmen who are transporting their goods from Guimaras to Negros and vice versa have expressed their inconvenience for the stoppage of the operation of the said facility;*

*WHEREAS, this Honorable Body feels the need to reactivate the operation of the Roro to have easy access for tourists who prefer to bring with them their vehicles while on vacation in Guimaras and likewise Guimarasnons who wish to have vacation in Negros province;*

*WHEREAS, the operation of the Roro facility will ensure additional influx of tourists from Negros and other nearby provinces; thus bringing additional tourism receipts in this province;*

*WHEREAS, the Honorable Governor, in his letter dated March 3, 2015 has endorsed to this Honorable Body the proposal of FF Cruz and Company, Inc. to engage on Roro transport operations using the Landing Craft Transport (LCT) from Port of Sibunag to Port of Pulupandan and vice versa;*

WHEREAS, this Honorable Body after being enlightened by the representatives of the FF Cruz on the features of their Landing Craft Transport, feels the need to endorse the same to the concerned agencies.

NOW, THEREFORE, on motion of Honorable John Edward G. Gando, Chairperson, Committee on Infrastructure, unanimously seconded;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:


