RESOLUTION NO. 35

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2015-01, SERIES OF 2015 AUTHORIZING THE ANNUAL EXECUTIVE BUDGET OF THE MUNICIPALITY OF JORDAN, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2015-01 of the Municipality of Jordan authorizing its Annual Executive Budget for the General Fund involving an appropriation of Eighty Six Million Eight Hundred Ninety Thousand Pesos (P86.890,000.00) and the Special Accounts involving the amount of Five Million Seventy Five Thousand Eight Hundred Fifty Pesos (P5.075.850.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, unanimously seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2015-01, authorizing the Annual Executive Budget of the Municipality of Jordan. Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 2015-01 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

- 1. The Municipality has to observe the Personal Services cap pursuant to Section 325 (a) of RA 7160 and Local Budget Circular No. 98 dated October 14, 2011.
- 2. Projects funded under the 2015 20% Development Fund shall be subject to the provisions of the DILG-DBM Joint Memorandum Circular No. 2011-1 dated April 13, 2011.
- 3. The Local Disaster Risk Reduction and Management Fund shall be utilized solely for expenditures authorized under R.A. No. No. 10121 and its Implementing Rules. laws and regulations. NDRRMC-DBM-DILG Joint Memorandum Circular No. 2012-73 and COA Circular No. 2012-01.
- 4. Fund utilization for Intelligence and Confidential Expenses shall be in accordance with the DILG Memorandum Circular No. 99-65 dated April 23, 1999 and Memorandum Circular No. 99-100 dated June 15, 1999.
- 5. Items of appropriations mainstreamed subsumed in the General Fund Budget that specify GAD Plans, programs and projects shall be subject to Local Budget Memorandum No. 36 dated July 4, 2001 and Joint DBM NEDA/NCRFW Circular No. 2004-1.
- The allocation of at least 1% of the LGU's total budget plans, program and services that address the needs of older persons and persons with disabilities shall be in accordance with DBM-DSWD Joint Circular No. 2003-01 dated 28 April 2003.

RESOLVED FURTHER, to require the Municipality of Jordan to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of Jordan that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Jordan, for information.
