RESOLUTION NO. 36

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2015 AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2015 OF THE MUNICIPALITY OF NUEVA VALENCIA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 01, Series of 2015 of the Municipality of Nueva Valencia authorizing its Supplemental Budget No. 1, Calendar Year 2015 for the General Fund involving an appropriation of Two Million Three Hundred Eleven Thousand One Hundred Fifty Six Pesos and Six Centavos (P2,311,156.06) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of SP Member John Edward G. Gando, unanimously seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 01, Series of 2015 authorizing the Supplemental Budget No. 01, Calendar Year 2015 of the Municipality of Nueva Valencia, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 01, Series of 2015 subject to the posting requirements under Section 59 of R. A. No. 7160, and subject further to the following conditions:

1. *The grant of Collective Negotiation Agreement (CNA) to Municipal Officials and Employees shall be in accordance with the provisions of Budget Circular No. 2014-2 dated December 2, 2014.*
2. *The disbursement of funds for this Supplemental Budget shall not exceed the amount authorized in the Appropriation Ordinance.*

RESOLVED FURTHER, to require the Municipality of Nueva Valencia to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of Nueva Valencia that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Nueva Valencia, for information.


