 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 5. A complete set of Bidding Documents may be acquired by interested bidders on <u>April 27,2017</u> from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Five Thousand Pesos only (P5,000)</u>.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

 the acceptable forms and in the amount stated in ITB Clause 18.
 - Bid opening shall be on <u>9:30A.M.</u> at <u>BAC Office</u>, <u>Door 1</u>, <u>Covered Gym</u>, <u>San Miguel</u>, <u>Jordan</u>, <u>Guimaras</u>. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The <u>Province of Guimaras</u> reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
