- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- A complete set of Bidding Documents may be acquired by interested bidders on <u>April 27,2017</u> from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Five Thousand Pesos only (P5,000)</u>.

Bid opening shall be on <u>9:30A.M. May 18,2017</u> at <u>BAC Office</u>, <u>Door 1, Covered Gym</u>, <u>San Miguel</u>, <u>Jordan</u>, <u>Guimaras</u>. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
