**RESOLUTION APPROVING AND ADOPTING RESOLUTION NO. 1, SERIES OF 2016 OF THE PDC ENTITLED: APPROVING THE INCLUSION OF ADDITIONAL PRIORITY SUB-PROJECTS OF ₱5 MILLION UNDER THE PROVINCIAL COUNTERPART TO THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP), AND INCREASE IN INVESTMENT REQUIREMENT OF THE WATER SUPPLY PROGRAM TO ₱15 MILLION IN THE ENHANCED 2014-2019 PROVINCIAL DEVELOPMENT INVESTMENT PROGRAM (PIDP)**

*WHEREAS, the Honorable Governor, in his letter dated 13 January 2016, has endorsed to this Honorable Body, PDC Resolution No. 1 on the inclusion of additional priority sub-projects of ₱5M under the PRDP and increase in investment requirement of the Water Supply Program to ₱15M in the Enhanced 2014-2019 PDIP;*

*WHEREAS, the sub-projects in the amount of ₱5M include: Cupo-San Isidro-Malbang-Dasal and Ravina-Ayangan FMRs, Sibunag-Tamborong-Constancia FMR, San Lorenzo-Mura-Daragan FMR, Jordan and Buenavista; and to change Lucmayan-San Roque road section to Lucmayan-San Roque-Lapaz road section, Nueva Valencia;*


