**RESOLUTION AUTHORIZING GOV. SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR
AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS, THE
MEMORANDUM OF AGREEMENT WITH THE GUIMARASNON FOOD PRODUCERS,
INC. (GFPI) FOR THE MANAGEMENT OF THE GTIC SHOWROOM PASALUBONG
CENTER**

*WHEREAS, the Honorable Governor, in his letter dated 29 June 2016 has requested for
an authority to sign for and in behalf of the Provincial Government of Guimaras the MOA with
the Guimarasnon Food Producers, Inc. (GFPI) as regards the management of the GTIC
Showroom Pasalubong Center;*

*WHEREAS, the MOA provides among others, that GFPI shall allow other products
produced and processed in Guimaras to be displayed and will share to the provincial government
60% of its profits;*

WHEREAS, this Honorable Body interposes no objection to such request;

*NOW, THEREFORE, on motion of Hon. Diosdado G. Gonzaga, Chairperson, Committee
on Agriculture, duly seconded;*

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED;

*RESOLVED, to authorize Gov. Samuel T. Gumarin, MD, MPH to sign for and in behalf
of the Provincial Government of Guimaras, the following;*

MEMORANDUM OF AGREEMENT

KNOW ALL WOMEN AND MEN BY THESE PRESENTS:

This Memorandum of Agreement is entered into by and between:

The PROVINCE OF GUIMARAS with office address at the Provincial Capitol Building, San Miguel, Jordan, Guimaras, represented herein by Honorable Governor Samuel T. Gumarin, MD, MPH, hereinafter referred to as the First Party;

-and-

The GUIMARASNON FOOD PRODUCERS, INC. with SEC Registration No. CN201637923 with office address at San Miguel, Jordan, Guimaras represented herein by its President, Mr. Teodoro S. Ganancial, Jr. hereinafter referred to as the Second Party.

W I T N E S S E T H :

WHEREAS, the Local Government Code provides that every local government unit shall ensure support to enhance economic prosperity:

WHEREAS, the provincial government in its effort to promote Guimaras Products is in full support of the Guimaras Producers in the promotion of Guimaras processed products in the province, which enhance the economic prosperity of the province:

WHEREAS, the provincial Government of Guimaras thru its Provincial Economic Development Office (PEDO) and the Office of the Governor (GO) as cooperating departments shall technically assist and facilitate capability building on marketing, organizational and business development concerns of the Guimarasnon Food producers, Inc.;

WHEREAS, the Guimarasnon Food Producers Inc. a group of processors in the Province of Guimaras organized and registered with SEC with Registration Number CN201637923 dated April 29, 2016 had intended to manage the GTIC Showroom Pasalubong Center since January 2015;

WHEREAS, part of the support pledged by the Provincial Government of Guimaras to the Guimarasnon Food Producers Inc. is the turnover of the management of GTIC Showroom Pasalubong Center as agreed during a meeting of the Guimarasnon Food Producers Inc. Representatives with the Governor held on June 17, 2016;

WHEREAS, the Guimarasnon Food producers Inc. shall manage the GTIC Showroom Pasalubong Center within the Business Resource Center located at the GTIC Building and it is willing to share the net profit from the GTIC Showroom Pasalubong Center and shall manage the showroom section in support of all the producers and processors in the province of their marketing and promotional transactions;

WHEREAS, the Guimarasnon Food producers Inc. will allow up and coming enterprises endorsed by the PEDO to display at the GTIC Showroom/Pasalubong Center as per terms and conditions agreed;

WHEREAS, NOW THEREFORE, in consideration of above-mentioned premise, the parties herein have agreed to the following terms and conditions:

a. Obligations of the First party

1. Provide the venue including the existing furniture and fixtures for display and sale of Guimaras Processed products located at the GTIC Building owned by the First Party.
2. Provide technical assistance to the Second Party in its Capacity Building in the area of Marketing, Organizational Development and Business Management thru its Provincial Economic Development Office.
3. Shall conduct annual monitoring and evaluation activities on the progress of the implementation and organizational growth.

b. Obligation of the Second Party

1. Shall be responsible in the management of the project including the Manpower requirement and other showroom operation and management requirements;

2. Shall not remove any of the furniture and fixture owned by the Provincial Government or renovate the GTIC Showroom Pasalubong Center without the written consent from the Provincial Government.
3. Will share Sixty percent (60%) of the net profit from the sales/proceeds of the goods displayed in the GTC Showroom Pasalubong Center with the Provincial Government.
4. Shall submit annual report to the First party for Monitoring and Evaluation purpose thru its implementing agency/department the PEDO.

c. Effectivity

1. This MOA shall take effect upon signing of the parties hereto, and shall remain in force and effect for Three (3) years from the date of execution.
2. The First party may initiate the termination of the same for cause or causes deemed by the First Party.
