RESOLUTION NO. 107

RESOLUTION REQUESTING THE HONORABLE CONGRESSWOMAN, MA. LUCILLE L. NAVA, MD, OF THE LONE DISTRICT OF GUIMARAS, FOR FUNDING ALLOCATION FOR THE CONSTRUCTION OF THE SANGGUNIANG PANLALAWIGAN LEGISLATIVE BUILDING

WHEREAS, with the utmost desire to effectively provide all the necessary legislative support to the Executive Branch headed by the HON. GOVERNOR SAMUEL T. GUMARIN, MD, MP, LL, the Office of the Sangguniang Panlalawigan now under the leadership of HON. VICE GOVERNOR ATTY. JOHN EDWARD G. GANDO, has already enacted various legislative measures necessary for the realization of the programs and projects advocating for good local governance in the entire Province. As a sign of commitment to uphold the highest level of professionalism in terms of public service, the Sangguniang Panlalawigan has facilitated various innovations to upgrade the its service and the performance of its functions, which will soon be observed the moment all the required facilities are put in place;

WHEREAS, secondary to safety and security issues are the vital documents, equipment and properties of the Sanggunian that we have all sworn to take care and protect;

WHEREAS, it is on these disquisitions, that the 8th Sangguniang Panlalawigan humbly requests the gracious Congresswoman of the Lone District, HONORABLE LUCILLE LEDESMA NAVA, MD, and with the representation HON. GOVERNOR SAMUEL T. GUMARIN, MD, MPH, for funding allocation for the construction of a new Legislative Building for the Sangguniang Panlalawigan of Guimaras;
