**RESOLUTION AUTHORIZING GOV. SAMUEL T. GUMARIN, MD, MPH, TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS, THE MEMORANDUM OF AGREEMENT WITH BUENAVISTA WATER DISTRICT FOR THE RELEASE OF THE AMOUNT OF ₱62,000.00 AS FINANCIAL ASISSTANCE TO THE “PIPELINE EXTENSION” TO PUROK ILANG-ILANG, SUPANG, BUENAVISTA**

WHEREAS, the Buenavista Water District in its desire to deliver adequate, affordable and reliable water supply, needs to extend its pipelines to Purok Ilang-ilang, Supang, Buenavista;

WHEREAS, the Provincial Government of Guimaras with its obligation to ensure the delivery of basic services to its people, will be extending financial assistance to the Buenavista Water District for the pipeline extension to Purok Ilang-ilang, Supang, Buenavista in the amount of ₱62,000.00;

WHEREAS, there is a need of a responsible official to sign the Memorandum of Agreement drafted for the purpose;

This PROVINCIAL GOVERNMENT OF GUIMARAS with address at San Miguel, Jordan, Guimaras as represented by its Governor, Hon. Samuel T. Gumarin, MD, MPH of legal age, Filipino, married and a resident of Buenavista, Guimaras herein referred to as the FIRST PARTY:

The BUENAVISTA WATER DISTRICT represented by Engr. Dione J. Gabayoyo, General Manager with office address at New Poblacion, Buenavista, Guimaras herein referred to as the Second Party;

WITNESSETH

WHEREAS, human life, as with all animal and plant life on the planet, is dependent upon water. Not only do we need water to grow our food, generate our power and run our industries, but we need it as a basic part of our daily lives-our bodies need to ingest water every day to continue functioning;

WHEREAS, Communities and individuals can exist without many things if they have t-they can be deprived of comfort, of shelter, even of food for a period, but they cannot be deprived of water and survive for more than a few days;

WHEREAS, because of the intimate relationship between water and life, water is woven into the fabric of all cultures, religions and societies in myriad ways;

WHEREAS, the First party being a Local Government Unit has the obligation to ensure the delivery of basic services under paragraph 4 of Section 463 in accordance with Section 17 of the Local Government Code;

WHEREAS, the Second Party tasked in the delivery of adequate, affordable and reliable water supply needs to implement more programs such as a "pipeline extension" to Purok Ilang-ilang, Brgy. Supang, Buenavista, Guimaras;

WHEREAS, the First Party recognizing the needs of the constituents and in the furtherance of basic services will release the amount of P62,000.00 as financial assistance to the "pipeline extension" to Purok Ilang-Ilang, Brgy. Supang, Buenavista, Guimaras subject to auditing rules and regulations.


