**RESOLUTION APPROVING AND ADOPTING PDC RESOLUTION NO. 3, SERIES OF 2016, APPROVING FOR ADDITIONAL FUNDING, THE PROVINCIAL COUNTERPART TO PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) AND THE WATER SUPPLY PROGRAM TO BE TAKEN FROM THE UNPROGRAMMED AMOUNT OF ₱7,609,761.64 OF THE 20% DEVELOPMENT FUND FOR CY 2016**
