RESOLUTION NO. 110

RESOLUTION ENJOINING ALL CONSTITUENTS THROUGH THE ABLE LEADERSHIP OF THE PUNONG BARANGAYS IN THE PROVINCE OF GUIMARAS TO UNDERTAKE THE CLEAN-UP OF THEIR SURROUNDINGS ON JULY 30, 2016 AT 4:00 O'CLOCK IN THE AFTERNOON AND THEREAFTER, THE SAME HABIT SHALL BE PRACTICED AS THE NEED ARISES TO PREVENT THE OUTBREAK OF DENGUE

WHEREAS, dengue is reported as one of the leading causes of hospitalization not only among children but also adults and is being transmitted through aedes mosquito infected with a dengue virus;

WHEREAS, peak incidence of dengue cases occurs during the rainy season and rainfall correlates significantly to dengue incidence;

WHEREAS, as of June of 2016 there are 26 reported cases of admission at the Doctor Catalino Gallego Nava Provincial Hospital and 2 were referred to the city hospital;

WHEREAS, to reduce the mosquito population, there is a need for a high level concern, a concerted effort, a mass action to get rid of places where mosquitos can breed;

NOW THEREFORE, on motion of Honorable Josefina G. de la Cruz, Vice Chairperson, Committee on Health, unanimously seconded,

THE 8th SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to enjoin all constituents through the able leadership of the Punong Barangays in the Province of Guimaras to undertake the clean-up of their surroundings on July 30, 2016 at 4:00 o'clock in the afternoon and thereafter, the same habit shall be practiced everyday as the need arises to prevent the outbreak of dengue

RESOLVED FURTHER, to send a copy of this resolution to all Punong Barangays, and all others concerned, for information and favorable action.
