RESOLUTION NO. 12

RESOLUTION DECLARING ORDINANCE NO. 2015-063 OF THE MUNICIPALITY OF SIBUNAG ENTITLED: "AN ORDINANCE REQUIRING ALL PREGNANT WOMEN TO UNDERGO PRENATAL AND POSTNATAL SERVICES AND GIVE BIRTH AT DESIGNATED BIRTHING CENTERS IN THE MUNICIPALITY OF SIBUNAG" AS VALID AND WITHIN THE POWER OF TIAT SANGGUNIAN TO ENACT WITH A COLATILLA THAT THE SAME SHOULD BE PUBLISHED IN THE NEWSPAPER OF GENERAL CIRCULATION

WHEREAS, for the consideration of this Honorable Body is Municipal Ordinance No. 2015-063 of the Municipality of Sibunag entitled: "An Ordinance Requiring All Pregnant Women to Undergo Prenatal and Postnatal Services and Give Birth at Designated Birthing Centers in the Municipality of Sibunag;"

WHEREAS, the Committee on Health and Social Services to where said Ordinance was referred, rendered a committee report of even date, recommending that Ordinance No. 2015-063 be declared valid as it is within the power of that municipality to enact, with a collatilla that the same has to be published in the newspaper of general circulation;
