RESOLUTION NO. 129

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 05, SERIES OF 2016 AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 02, YEAR 2016 OF THE GENERAL FUND OF THE MUNICIPALITY OF NUEVA VALENCIA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS. Appropriation Ordinance No. 05, Series of 2016 of the Municipality of Nueva Valencia authorizing its Supplemental Budget No. 02, Year 2016 for the General Fund involving an appropriation of One Million Two Hundred Eighty Thousand Pesos (P1.280.000.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160:

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of Hon. David G. Gano, unanimously seconded;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED. to declare Appropriation Ordinance No. 05, Series of 2016 authorizing the Supplemental Budget No. 02, Year 2016 of the Municipality of Nueva Valencia, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 05, Series of 2016, subject further to the posting requirements under Section 59 of R.A. No. 7160.

RESOLVED FURTHER, to require the Municipality of Nueva Valencia to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of Nueva Valencia that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Nueva Valencia for information.
