**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 01-2016 AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 04-2016 OF THE GENERAL FUND OF THE MUNICIPALITY OF SIBUNAG, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

WHEREAS, Appropriation Ordinance No. 01-2016 of the Municipality of Sibunag authorizing its Supplemental Budget No. 04-2016 for the General Fund involving an appropriation of Two Million Two Hundred Ten Thousand Pesos (P2,210,000.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of Hon. David G. Gano, unanimously seconded;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 01-2016 authorizing the Supplemental Budget No. 04-2016 of the Municipality of Sibunag, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 01-2016, subject further to the posting requirements under Section 59 of R.A. No. 7160.

RESOLVED FURTHER, to require the Municipality of Sibunag to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of Sibunag that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.


RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Sibunag for information.
