RESOLUTION REQUESTING THE SECRETARY OF THE DEPARTMENT OF FINANCE THROUGH THE EXECUTIVE DIRECTOR OF THE BUREAU OF LOCAL GOVERNMENT FINANCE TO CONSIDER THE GENERAL INCOME RECLASSIFICATION OF ALL LOCAL GOVERNMENT UNITS ALL OVER THE COUNTRY

WHEREAS, this Honorable Body is in receipt of Resolution No. 2016-073 of the Province of Aklan entitled: "A Resolution Reiterating Request to the Secretary of the Department of Finance Through the Executive Director of the Bureau of Local Government Finance to Promptly Consider the General Income Reclassification of All Government Units All Over the Country";

WHEREAS, such resolution is seeking the support of all the Sangguniang Panlalawigan in the country and the push for the Bureau of Local Government Finance (BLGF) to promptly classify LGUs or the congress for the passage of the corresponding legislation;

WHEREAS, the 8th Sanggunaing Panlalawigan of the Province of Guimaras also believes that it is but appropriate that the general income reclassification of all LGUs be fasttracked, as it has been held in abeyance for quite some time;
