**RESOLUTION REQUESTING THE SECRETARY OF THE DEPARTMENT OF FINANCE THROUGH THE EXECUTIVE DIRECTOR OF THE BUREAU OF LOCAL GOVERNMENT FINANCE TO CONSIDER THE GENERAL INCOME RECLASSIFICATION OF ALL LOCAL GOVERNMENT UNITS ALL OVER THE COUNTRY**

WHEREAS, this Honorable Body is in receipt of Resolution No. 2016-073 of the Province of Aklan entitled: "A Resolution Reiterating Request to the Secretary of the Department of Finance Through the Executive Director of the Bureau of Local Government Finance to Promptly Consider the General Income Reclassification of All Government Units All Over the Country";


THE 8<sup>TH</sup> SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:



ADOPTED. January 10, 2017.


